Introduction

Welcome to the mind-blowing world of EU politics!

Once a small club of six western European countries, the EU has grown to encompass the bulk of the European continent. Today, the EU deeply affects the policies and politics of its member states. At the same time, it challenges us political scientists to rethink focal concepts of political science such as "the state" and "democracy," and to understand the mechanisms underpinning policy-making in such a complex and composite polity. The Danish Presidency of the Council of the European Union is an invitation for you to step back from the traditional world of nation-state politics and enter the multi-cultural, multi-linguistic, and multi-level world of EU politics.

The Presidency of the Council of the European Union is the "creature" of the member states. It is an institutional device giving them, on paper at least, a "chance to influence the EU agenda, provide impetus to the EU system, and strengthen support for the EU in the Member States" (http://eu2012.dk/en). In practice, however, this task is truly formidable as: the EU is now a very large and diverse community of 27 members; presiding the Council is institutionally and politically very demanding; and six months is very little time to accomplish anything. Responding to growing criticisms of inefficiency and lack of democratic accountability, member states agreed in Lisbon in 2007 to reform the leadership of the EU by creating two new institutional figures alongside the traditional Presidency of the Council: the President of the European Council (currently President Van Rompuy) and the High Representative of the Union for Foreign Affairs and Security Policy (currently Lady Catherine Ashton). At the same time, they confirmed the spectacular rise of the European Parliament by making it a truly co-legislator of EU policy-making, on an equal footing with the Council of Ministers.

How have these changes affected the Presidency of the Council? How can member-states through the Presidency of the Council continue to exert leadership in increasingly globalized politics while creating more meaningful participation from ordinary Europeans?

Over five days, we will examine these issues in a broad range of settings, focusing on the political, economic, and institutional challenges facing the Danish presidency. We will focus in particular on the role of the Danish presidency in managing the euro crisis, preparing a compromise on budget issues in Brussels while engaging in the public debate on European integration at home. We have invited distinguished speakers—practitioners as well as scholars—to explain and witness how ordinary Europeans, as well as European politicians and civil servants make the EU work.

We will let you work out the implications of this amazing world of politics.
