The role of theory

- Theory is the foundation for your work
- You need to somehow contribute to extant theory
 - Test theory
 - Expand theory
 - Contribute with moderating factors
 - Identify the boundaries of a theory
- Description of the theories developed by others \rightarrow Short and precise
- Theory development
 - Your analysis and discussion
 - Should go beyond the texts you have read

The role of data

- There are many sources of data and you can combine them if you wish
 - Primary and secondary data
 - Interview, archival material
 - Quantitative and qualitative material
- The purpose(s) of data
 - Test theory: data must be appropriate for your specific test
 - Expand theory: data on a new but related phenomenon/context
 - Contribute with moderating factors: explanations of deviations from theoretical predictions
 - Identify the boundaries of a theory: explanation of why a theory that should work does not apply to a phenomenon/context

Analysis and discussion


- This is where you demonstrate that you fulfill the higher-level learning objectives
 - Analyze
 - Discuss
 - Assess
 - Recommend
- Do not underestimate the time needed to develop a good analysis







How do we succeed in the market?

Need for a thoroughly founded strategy:

- What markets to focus on
- Requirements regarding software and HW, regulations and critical infrastructure safety
- Recommended unique selling points
- Ideal organization
- Relevant external partnerships sales, installation and service
- Price strategy and finance strategy towards customers
- Corporate funding strategy including investor and ownership strategy
