7. The Candidate Reform
The Head of Study went through the candidate reform with the new Study Board explaining the progress made in the last couple of years.
From 2028 some of our Cand Merc profiles will change to 1-year programmes (75 ECTS) and some will continue as 2-year programmes (120 ECTS). It will be an important task for the Study Board in the months to come.

8. Admission

Over the last years Cand Merc has had a rise in the number of students from countries outside EU. There were some linguistic and academic challenges and some years back Cand Merc changed the admission policy to ensure that the students coming to study at Cand Merc had the correct academic level.

All over Denmark there has been a significant increase in students from countries outside of EU and The Danish Ministry of Education now focuses on the same issues and have sent a list of suggested changes to all the universities giving the universities more tools to select the best candidates. The Ministry has set a maximum quota for each university in order to reduce the intake of students from countries outside EU.
