Several students claimed that no reading was pointed to them	It is true that we did not give exact pages, except some pdfs; however, there were two core books, and for one of them we did point the chapters students do NOT need to read. On the other hand, ethics is philosophical topic and you need to read widely to learn from different perspectives. It is not a 'factual' topic, which you learn and do. I have also earlier brought up that this course comes much too early in the curriculum- in the first semester. The students are not ready to discuss and reflect yet, they expect factual knowledge. There was a clear study plan and we went through why ethics is important, what are the main concepts, theories and frameworks, tools to analyze ethics. It is difficult to say what the comments mean but we understand that it was the number of new concepts and tools which confused them. Also, we added an online part, which the stu- dents replying this survey in open answers, did not really use/understand. The separate survey on online part gave rather positive feedback. We attach the re- port on the online part done separately for the e- learning office.
