
Guidelines for the elections to the collegiate bodies of the University, autumn 2020

For these elections, eligible voters are divided into the following election groups:

The Board of SDU:	Election Group III
The University Council:	Election Groups II and III
Academic Councils:	Election Groups I, II and III
Department Councils:	Election Groups I, II and III
Boards of Study and PhD Committees:	Election Group III
SDU's Appointment Body:	Election Group III

Election Group I is comprised of academic staff and lecturers; Election Group II is comprised of technical/administrative staff and Election Group III is comprised of students enrolled at the University.

For the **Board of SDU**, representatives from Election Group III must be elected for a 2-year term.

For the **University Council**, representatives from Election Group II must be elected for a 4-year term and from Election Group III for a 2-year term.

For the **Academic Councils**, representatives from Election Group I and II must be elected for a 4-year term and from Election Group III for a 2-year term. At least 3 out of 5 seats in Election Group I must be occupied by recognised researchers at associate professor level as a minimum.

For the **Department Councils**, representatives from Election Group I and II must be elected for a 4-year term and from Election Group III for a 2-year term. At least 3 out of 5 seats in Election Group I must be occupied by recognised researchers at associate professor level as a minimum.

For the **boards of study and PhD committees**, representatives from Election Group III must be elected for a 1-year election period. Elections to the PhD committees are equated with elections to the boards of study.

For the **Appointment Body**, one representative must be elected by and from among the students who cannot be a member of the Board of SDU. The term of office is 2 years, with the possibility of reappointment. You can serve for a maximum of 4 years.

Election lists:

Employees belonging to Election Groups I and II are included on the election lists if the following conditions are met:

- (a) the person concerned is employed when the election is called and held; and
- b) the term of employment is at least 2 years, of which a period of no less than 6 months extends into the term of office, and
- (c) the employment is for at least 15 hours per week.

Students are admitted to the election list if they are enrolled at the University with a view to completing an overall course of study when the election is called and held: Bachelor, Graduate, Master's, elective subjects and the PhD programme. Students who are enrolled as guest students, on exchange stays or propaedeutic courses are not included on the election list.

No one in Election Group III may be eligible for election and have voting rights for more than one academic council. Persons who meet the requirements for being eligible for election to several academic councils may, within a period set by the Election Secretariat, communicate to the Election Secretariat in which voting area they wish to exercise their eligibility. If no such notice is given, the Election Secretariat will place the person in an election area.

Students who are enrolled in more than one course of study will automatically be registered with voting rights for the study board for the central part of the programme's subject areas. Upon submitting a written application, the student can be transferred to obtain voting rights for the study board which is responsible for the elective subject. Applications for transfer must be submitted to the Election Secretariat no later than the expiry of the deadline for complaints concerning the election lists (29 October 2020 at 12:00 noon).

Students are admitted to the election list with voting rights for the department council(s) at departments which provide a significant part of the subject disciplines that make up the student's education programme.

In the case of election to a PhD committee, PhD students constitute Election Group III, while they are included in Election Group I for elections to the department councils and academic councils.

Election information

The primary source of information regarding the elections will be the University's website for staff and students, respectively. In the weeks leading up to the elections, the website will feature a link to the elections. The election website for the students is: <https://mitsdu.dk/en/valg>. Students following a Master's degree programme in rehabilitation, fitness and training, a Master's degree in quality and management in the social and health sector or a Master's degree in medical imaging have voting rights for the Study Board for further and continuing education at the Faculty of Business and Social Sciences and the Faculty of Health Sciences

Students following a master's degree programme in pharmacy have voting rights for the Study Board for Pharmacy.

Students following a Bachelor's or Master's degree programme in Audiology have voting rights for the Study Board for Audiology.

Psychology students have voting rights for the Study Board for Psychology.

Students who study physiotherapy, occupational therapy, midwifery and clinical nursing have voting rights for the Study Board for Occupational Therapy, Physiotherapy, Midwifery, Clinical Nursing and the Master's degree programme in Health Sciences.

PhD students have voting rights for the PhD committee at the Faculty of Health Sciences.

Students at the Faculty of Business and Social Sciences:

Students studying for an MSc in Economics & Business Administration in Odense; MSc in Business Administration and Auditing and registered public accountant in Odense; MSc in Information Technology; BSc in Economics and Business Administration (dat) or BSc in Economics and Business Administration in Odense; BSc in Economics and Business Administration (dat) have voting rights for the Study Board for Business Economics.

Students studying for a BSc in Economics and Business Administration in Esbjerg; BSc in Economics and Business Administration – Sports and Event Management in Esbjerg and MSc in Economics & Business Administration in Esbjerg have voting rights for the Study Board for Business Economics.

Students studying for a BSc in Business Administration in Kolding; Design Management; MSc in Economics & Business Administration in Kolding; MSc in Economics & Business Administration and Auditing and registered public accountant in Kolding have voting rights for Study Board for Business Economics.

Students studying for a BSc in Business Administration (in English) and MSc in Business Administration in Sonderborg have voting rights for the Study Board for Business Economics.

Students studying for a BSc in Business Administration in Slagelse, BSc in Economics and Business Administration – Sports and MSc in Business Administration in Slagelse have voting rights for the Study Board for Business Economics.

Students studying for a BSc in Law (incl. Open University), Master of Law, BSc (Business Administration and Commercial Law) and Master of Business Law have voting rights for the Study Board for Law.

Students studying for a BSc and MSc in Economics or a BSc/MSc in Mathematics-Economics have voting rights for the Study Board for Market and Management Anthropology, Economics, Mathematics-Economics and Environmental and Resource Management.

Students studying journalism have voting rights for the Study Board for European Studies, Journalism, Sociology and Political Science.

Students studying for a Bachelor and Master's degree in Environmental and Resource Management have voting rights for the Study Board for Market and Management Anthropology, Economics, Mathematics-Economics and Environmental and Resource Management.

Students studying for a BSc and MSc in Political Science, main subject/central subject in Social Sciences and students studying for an MSc (Social Science) in International Security and Law have voting rights for the Study Board for European Studies, Journalism, Sociology and Political Science.

Students studying for an MSc in Social Sciences in Comparative Public Policy and Welfare Studies, a Bachelor and Master's degree in European Studies, as well as a Bachelor degree in Sociology and Cultural Analysis and a Master's degree in Cultural Sociology have voting rights for Study Board for European Studies, Journalism, Sociology and Political Science.

Students studying for a Bachelor of Market and Management Anthropology degree have voting rights for the Study Board for Market and Management Anthropology, Economics, Mathematics-Economics and Environmental and Resource Management.

Students studying design management have voting rights for the Study Board for Design, Tourism & Cross Border Studies.

Students enrolled in an MSc programme in social sciences or a Graduate Diploma in Business Administration programme have voting rights for the Study Board for further and continuing education in Social Sciences and Health Sciences.

PhD students have voting rights for the PhD committee at the Faculty of Business and Social Sciences.

Students at the Faculty of Humanities:

Students studying for an MA in Business, Language and Culture in Odense have voting rights for the Study Board for Negot.

Students studying for an MA in Business, Language and Culture in Sonderborg have voting rights for the Study Board for Negot.

Students studying for an MA in Business, Language and Culture in Esbjerg or Kolding have voting rights for the Study Board for Design, Tourism & Cross Border Studies.

Students studying Danish in Odense and Kolding have voting rights for the Study Board for Danish.

Students studying German or Spanish have voting rights for the Study Board for German and Spanish.

Students studying English as well as students studying American studies have voting rights for the Study Board for English and American Studies.

Students studying media studies have voting rights for the Study Board for Media Science.

Students studying culture and communication have voting rights for the Study Board for Cultural Studies.

Students studying Comparative Literature have voting rights for the Study Board for Comparative Literature.

Students studying design culture, design culture and economics as well as design studies have voting rights for the Study Board for Design and Tourism.

Students studying History, Classical Studies or Maritime Archaeology have voting rights for the Study Board for History, Classical Studies and Maritime Archaeology.

Students studying Web Communication, Information Science, International Business Communication as well as Library Science and Knowledge Communication have voting rights for the Study Board for Information and Communication Studies.

Students studying International Business Communication (Odense and Slagelse) as well as students studying professional bachelors in Language and IT-based Marketing Communication have voting rights for the Study Board for International Business Communication.

Students studying philosophy have voting rights for the Study Board for Philosophy.

Students studying for a BA Int., MSc in Business, Language and Culture or a BA in Int. Business Communication with Linguistic and Cultural Dissemination or for a MA Business Language degree in Communication Design in Sonderborg and Flensburg have voting rights for the Study Board for Cross-Border Studies.

Students studying Medieval Archaeology as a part-time study or Classical Studies (Classical Civilisation/Latin/Greek) have voting rights for the Study Board for History, Classical Studies and Maritime Archaeology.

Students studying Logopaedia, Audiologopaedia have voting rights for the Study Board for Audiologopaedia.

Students studying Modern Middle East and Muslim Studies or for a Master's degree in Globalisation and Integration have voting rights for the Study Board for Modern Middle East and Muslim Studies.

Students studying for a Master's degree in upper secondary education or in children's and youth culture or a master's degree in paedagogy, as well as students studying for a BSc in intercultural paedagogy, have voting rights for the Study Board for Paedagogy.

Students studying religion studies have voting rights for the Study Board for Religion Studies.

PhD students have voting rights for the PhD committee of the Faculty of Humanities.

Students at the Faculty of Science:

Students following a Bachelor, Graduate or Master's degree programme in Mathematics, Applied Mathematics, Computer Science, Data Science, Physics, Chemistry, Biology as well as Biochemistry and Molecular Biology have voting rights the Study Board for Science.

Students studying for a Bachelor's degree in Pharmacy have voting rights for the Study Board for Pharmacy.

PhD students have voting rights for the PhD committee at the Faculty of Science.

Students at the Faculty of Engineering:

Students following a Bachelor of Engineering or MSc in Engineering programme as well as students studying a technical Master's programme have voting rights for the Study Board for the education programmes at the Faculty of Engineering.

PhD students have voting rights for the PhD committee at the Faculty of Engineering.

Organisation, deadlines, etc.:

Eligibility

Eligible to vote is anyone who on 17 September 2020 belongs to one of the above-mentioned election groups, i.e. is employed as a full-time or part-time lecturer or academic staff member, technical/administrative staff member or enrolled as a student at the institution for the completion of a coherent education programme, and who is still employed or enrolled at the time the election is held and who is otherwise included on the election list. Students who are enrolled as guest students, single-subject students or in propaedeutic courses are not granted voting rights.

Election lists

Election lists of those eligible to vote are prepared on the basis of the Staff and Payroll Office's registrations as well as registrations in STADS (the student register) and will be available **from 21 October 2020**.

To be able to vote and be eligible for election, those eligible to vote must be included on the election lists. Students on leave are not eligible to vote.

Objections to the election lists must be submitted in writing to the Election Secretariat no later than 29 October 2020 at 12:00 noon. Objections must be substantiated and possibly accompanied by documentation. After 29 October 2020 at 12:00 noon, changes to the election lists cannot be called for. However, it should be noted that the Election Secretariat will correct obvious errors and omissions on the election lists right up to the end of the election process.

The result of the Election Committee's processing of any complaints will be communicated to the complainants no later than 2 November 2020.

Affiliation with multiple uniform bodies and multiple areas of representation

Students (Election Group III) enrolled in more than one study subject, e.g. German and Sports, Chemistry and English, Medicine and Philosophy, English and Business Languages and the like will be listed with voting rights for the central subject. If the student instead wishes to exercise his/her right to vote within an elective subject, the student must apply for this **before 29 October 2020 at 12.00 noon** and notify the Election Secretariat within which study board/area of representation they are seeking voting rights.

No one may vote or stand for election in more than *one area of representation*. If anyone has affiliation with more than one area of representation, the person in question must, no later than 29 October 2020 at 12:00 noon, notify the Election Secretariat in writing of where he/she wishes to exercise his or her right to vote.

If the above notices are not issued, the Election Secretariat decides where the right to vote can be exercised.

Election methods, division into areas of representation

Elections to the collegiate bodies take place by proportional representation election.

A majority of the representatives of the individual election areas of the Board, the University Council, academic councils, study boards and department councils can decide that for their area, the election area should be divided into smaller election areas (areas of representation).

The decision on the division of areas of representation must be communicated to the Election Secretariat no later than 24 September 2020 at 12:00 noon. Publication will take place on 28 September 2020. If a decision on division into areas of representation has not been announced by 24 September, the election will take place as a proportional representation election between lists without division into areas of representation.

Requests for the annulment of division of areas of representation must be submitted to the secretary of the Election Committee no later than 2 October 2020 at 12:00 noon. Divisions of areas of representation may be declared void by a number of eligible voters on $S/(M+1)$, where S is the number of eligible voters and M is the number of seats. However, 25 eligible voters can always demand the division annulled.

By 5 October 2020, the Election Secretariat will announce whether any requests for the annulment of divisions of areas of representation can be granted.

Candidate listings

Candidate lists must be submitted to the Election Secretariat **no later than 9 November 2020 at 12:00 noon**.

Candidate lists can be prepared and submitted to the Election Secretariat electronically or on (paper) forms. Electronically prepared candidate lists are produced by accessing:

Please note that electronic candidate registration is unavailable until the election lists have been published on 21 October 2020.

Forms for use in the traditional candidate nomination method can be downloaded from the election website or requested by contacting the Election Secretariat.

In the case of elections to collegiate councils and study boards, the proposals must be signed by a minimum of 5 and a maximum of 20 eligible candidates within the area in question. However, ¼ of the eligible candidates within an area of representation is always considered a sufficient number of candidates. In the case of elections to the Board, the proposals must be signed by a minimum of 25 and a maximum of 40 eligible voters within the area in question.

No one can be a nominator for multiple candidates/candidate lists within an area of representation. Candidates are automatically nominators for the list on which they are listed.

A candidate list cannot contain more than twice the number of candidates to be elected. However, up to 10 candidates can always be nominated. No candidate may be nominated on more than one list for the same collegiate body.

A candidate list may, at the same time as the list is submitted, request the assignment of a list designation. If no such request is made, the Election Committee may determine a list designation.

It must appear from the list (notification) who is responsible for the creation and submission of the list (notification), so that the Election Secretariat can contact the person in question in case of doubt. If no such name is affixed, the Election Committee will consider the first nominator on the list to be the person responsible for the list.

To be valid, a candidate nomination or candidate list must contain:

- 1) Information on which body/position the candidate(s) is/are running for,
- 2) Information about the election group and any area of representation to which the nominated candidate(s) belong,

3) Information about the ranking of the candidates or whether the list is coordinated (unless it is directly stated on the list that coordinated listing applies, the candidates shall be ranked in the order in which they are listed),

4) The names and civil registration numbers of the nominated candidate(s) and the signature(s) of the person(s) concerned confirming that they are willing to accept election,

5) The names and civil registration numbers of the prescribed number of nominators and their signatures.

Candidate lists must be approved by the Election Committee and published by notice no later than 17 November 2020. Publication of candidate lists includes the names of nominators.

Objections to the published candidate lists must be submitted in writing to the Election Secretariat no later than 23 November 2020 at 12:00 noon

Cancellation of elections

If no more candidates are nominated within an election area or area of representation than are to be elected, the election within that election area (uncontested election) is cancelled. If all of the nominated candidates are listed on the same list, the election is cancelled, unless there is a coordinated listing of more candidates than the number to be elected. The Election Committee declares the candidates on the list to be elected in the order listed. Non-elected candidates are regarded as substitutes for the elected candidates.

The Election Secretariat will announce the cancellation of any elections no later than 17 November 2020.

Holding the election – including the option of postal votes

The election is held as an **e-election**, however, with the option of casting postal votes.

The electronic election process will take place in the period between 24 November 2020 at 9:00 AM and 25 November 2020 at 7:00 PM.

You can access the voting portal online via <https://e-valg.sdu.dk/>

Postal voting is possible if you are prevented from voting via e-election. Until 23 November 2020 at 12:00 noon, postal voting materials can be requested by submitting a written request to the Election Secretariat. The material will be sent/delivered immediately after 14 November and until the deadline for requisitioning ends on 21 November. The postal votes must be returned in a self-addressed envelope to the Election Secretariat's PO box and arrive no later than 26 November 2020 at 10:00 AM.
